- 4. As candidates need to be aware of what is being said on the Party's behalf, all Press Releases to be made available to candidates, with a minimum of 24 hours notice for response. Perhaps by Private Message via Facebook?
- 5. Donal suggests that, where the Party has no candidates, the FPCC would review candidates in such constituencies, & recommend to members, who they might support. This would give the Party some kudos with those candidates, in the event they were elected.
- 6. Donal suggests that the Manifesto needs revamping, being both too long, & with too many aims. A sub-group required to work on this, agreed that Donal, Niamh, Daniel, Damon, Cy & Cleo will do so, with the timescale for completion, in time for submission to the next convention.
- 7. Possible date for next convention: Saturday 2nd April 2016 (dependant on date of Easter Rising celebrations). City Galway (as seems the most straightforward for bulk of members to reach by road & rail), Shannon or Dublin. Cleo suggests a slightly earlier start time of 1pm, to allow members to depart in line with public transport, & nightfall.
